Submission Guidelines:

- The essay should be submitted in MS Word format. The font size should be Times New Roman with 12 pt. for the text with 1.5 line spacing.
- The word limit should not exceed more than 3000 words (excluding footnotes).
- The participants shall mail their essay with the subject, "3rd National Essay writing Competition- SLS Hyderabad".

- The Essay must be coupled with a separate document attached containing the information of the author – Full Name, Current year of the Study, Institute Name, Phone number and E-mail address.
- All submissions must be original and bonafide work of the participants and should not be submitted for any other competition or for any other purpose.
- Original views are strongly encouraged than excessive citations of published public information.
- The participants are required to scan a copy of the bonafide Certificate or an identity card duly issued by their respective Law school/University to the mail ID along with the essay.
- Co-authorship is allowed upto two members.
