- The article must be submitted in the English language only and must be in Microsoft word format (.doc/docx). The submission in any other language and format will be rejected summarily.
- The format and style of the article are as follows:
  1. Font Style- Times New Roman
  2. Font Size- 12
  3. Line Spacing- 1.5
  4. Foot Note size- 10
  5. Citations will be as per as bluebook 20<sup>th</sup> edition.
- All articles must be original and unpublished. However plagiarism up to 10% is allowed.
- The article shall be evaluated based on quality of content, knowledge of law, innovative ideas, originality, language and style.
